

# 2022-2023 Seasonal/Seapro Court Information



## How to Book

- **Step 1:** Decide which payment option works best for your **group**, Pay in Full Or Auto-pay program (**not available after 12/1 start**).
- **Step 2:** The captain is responsible for submitting a roster and court fee breakdown by player.
- **Step 3: Please submit your Captain form with court fee breakdown by player prior to making any payments.**
- **Step 4: Be sure to have all players submit forms and payments**

## Payment options for Your Seasonal/Seapro Court

Yonkers Tennis will accept payments from individual group members only if organized by the captain and submitted with the amount each player owes.

- You have two payment options:
  - **You and your group** can pay in full.
- **You and your group** can leave a **deposit** (1<sup>st</sup> installment) per court, per hour and take advantage of our auto-pay program. **If you have a pro on your court the fee/pro fee is a combined total.** Please be sure the Seasonal/Seapro Court Captain Form is returned prior to payments and Player Payment/Contract Form with payment options are completed. Submit all forms with payment to the front desk, or you can complete, sign and scan to [mlcummings@yonkerstennis.com](mailto:mlcummings@yonkerstennis.com).

## Auto-Pay Program

- If you plan on going on Auto-Pay, your remaining deposit/balance will be taken in equal monthly installments **September 1st through December 1st**. You must have a valid form of payment on file, Amex, Discover, Visa or Master Card. All financial information must be submitted with the player payment/contract.
- **Remember, the Seasonal/Seapro Court Player Payment/Contract Form must be completed for each player.**

## Pre-Paid Ball Program for Seasonal Courts only:

As a service to our customers, we offer premium grade tennis balls.

- The cost of the ball program is \$150.

## Seasonal/Seapro Court Agreement

- **Cancellations & Refunds:** You and your group may cancel this contract without further obligation and for a full refund within three days from the date of registration. From three days after registration through July 1st, cancelled courts will be refunded. **After July 1, 2022, the deposit will be non-refundable. After September 12, 2022 the entire court fee is non-refundable for cancelled courts.**
- **The club does not rent a "specific" court.** The club rents only the day and time on any available court. Courts may be reassigned at any time at the discretion of the management.
- Seasonal courts may only use the facilities' teaching staff. No outside teaching professionals are allowed to teach or use the facilities' teaching equipment.
- The group will be responsible for any applicable federal, state, or local taxes that might be levied against these fees during the course of the season. This responsibility will not be waived even if the taxes are levied retroactively. Fees currently collected do not include any such taxes.
- No rebate, credit or makeup time shall be due for loss of group's reserved court time due to circumstances beyond the control for Yonkers Tennis Center, such as acts of God, strikes, etc. Seasonal court time unused by the playing groups because of personal reasons or holidays cannot be made up. However, in the event you are unable to use your seasonal court time and wish to resell it, you must notify the club in writing. If any portion of the court is resold you will receive a makeup. As a courtesy, **a maximum of 3 prorated make-ups allowed per season, sign up by 9/1 (3), 12/1 (2) and 3/1(1)** and all makeups must be taken before the last day of Seasonal/Seapro Courts. The captain is responsible to check if the court was sold.
- Management reserves the right to provide instruction on adjacent courts.
- Management reserves the right to change all or part of this offering without prior notice.
- The use of the center is strictly at the player's risk. The center is not responsible for injuries, accidents or damage to any person or to personal property arising from normal athletic activities in the premises. All groups and their guests hereby waive any claims for damages arising from their use of center facilities.
- All players must complete a Covid waiver prior to participating.
