One thing comes to mind as we prepare for our seasonal renewals...team YTC is constantly looking to improve by investing in our club and most importantly our staff. President Joe Curto, Director of Tennis Coach Tendai, Assistant Director of Tennis Coach Vito and myself recently visited the USTA National Campus in Lake Nonna, FL (unfortunately we didn't bring back warmer weather). We met for several days with former GM Simon Gale and his staff to share ideas and gain knowledge on how to take things up a notch both on and off the court, providing you with the best possible product. Our goal is to constantly improve!

We're excited to introduce **NEW SAVINGS** for next season, *weekday "Early Bird 7-8am"* and *"Night Owl 9-10pm"* court rates will be offered at the *current 2023-24 rates!* Plus, an *additional SAVINGS* of \$345 for "Early Bird 7-8am" players booking a **second court** for **only \$999!** This is a wonderful opportunity to extend your current playing time or play twice a week so please take advantage of the savings. With that being said, all the information your group needs to complete the renewal process for 2024-25 follows this letter and is also on our website www.yonkerstennis.com. Kindly forward the information to your fellow players as only the captain receives this email. The rates are reflective of the current times and helps us retain and invest in our certified/experienced staff, who are all committed and eager to return next season!

A few things to keep in mind...

- **The renewal period will be ONE week from 2/11-2/17.** This will help us simplify the process and accommodate change requests in a timely manner. **Deadline: 2/17/24**
- Our season will begin on **Monday, September 16th**, continuing with a 30-week season which allows for longer outdoor play and time for Coaches to rest after grinding all summer!
- Please be sure to read and understand the policies on the contract form you are signing, including but not limited to makeups and non-refundable court fees **after May 1st**.
- We continue to take payments from **individual** players (vs captain only) and offer the very popular 5% PIF discount if the *entire group* pays in full by **February 17, 2024**.
- We also continue to offer an **installment plan**, with *no additional fees*, of 4 equal installments consisting of a 25% deposit then deductions on 10/1, 11/1 and 12/1.
- You'll notice once again we have made calculating your cost easier by listing each time slot by the hour. You'll also find a second-rate sheet which combines the court and coach rate for Seapro courts, so you don't have to 😊
- As always, priority renewals are for existing courts so please lock in your court by the deadline date of **February 17, 2024**. New court requests and changes will be **waitlisted** and taken care of on a first come, first serve basis.

2024-2025 Seasonal/Seapro Court Information Renewal Period 2/11-2/17, **deadline 2/17/24**



Attention "Early Bird 7-8am" and "Night Owl 9-10pm" players:

Weekday 7-8am and 9-10pm court rates are being offered at 23-24 rates for next season!!!

For our "Early Bird" players, Mon-Fri 7-8am time slot, we have an additional special.

If you chose to book two courts Mon-Fri 7-8am the fee for the 2nd court \$999, that's a savings of \$345.
1st court \$1344 + 2nd court \$999 = \$2343, for additional savings PIF 5% discount paid by 2/17 = \$2225.85, that's \$37.10 a session!!!

Same applies for Seapro courts Mon-Fri 7-8am, book two courts Mon-Fri 7-8am, save \$345 on the 2nd court.

Can't decide, book a seasonal and a seapro court Mon-Fri 7-8am.

Limited courts available, first come first serve. Coaches are subject to availability; Director fee additional \$699. Offer expires 2/17/24.

New: In order to simplify the Renewal process and accommodate change requests in a timely manner, the renewal period is one week this season, 2/11-2/17, **deadline 2/17/24.**

How to Register:

- **Step 1: Choose a Group Payment option:**
Decide which payment option works best for your **group, Pay in Full or Auto-pay program.**
- **Step 2: Submit a Court Captain Form:**
The Captain is required to submit a Court Captain Form complete with roster and fee breakdown by player.
prior to making any payments.
Easy rate sheet: Seasonal (Court only) and Seapro (Court & Pro combined) per hour by time slot.
- **Step 3: Player Payment/Contract:**
All players are required to submit a Player Payment/Contract.

Payment options for Your Seasonal/Seapro Group Court:

Yonkers Tennis will accept payments from individual group members **only if organized by the captain and submitted with the roster and fee breakdown by player.**

- There are two payment options for you and your **GROUP the deposit or full payment is due by 2/17/24:**
1. OPTION 1: PAY IN FULL: You and your group can pay in full.
2. OPTION 2: AUTO-PAY PROGRAM: You and your group can enroll in our Auto-Pay Program,
If your group is enrolling in the Auto-Pay Program your fee will be divided into **4** equal installments, 25% deposit upon confirmation, the remaining balance will be taken in 3 equal monthly auto-pay installments on 10/1, 11/1 and 12/1.
You must have a valid form of payment on file, Amex, Discover, Visa or Master Card to enroll in our Auto-Pay plan.
- All players must submit a signed/completed Player Payment/Contract to the front desk, convenient Drop Box or you can scan your form to mlcumming@yonkerstennis.com. Your deposit or full payment will be processed upon confirmation through our back office to avoid overcrowding at the front desk.

Pre-Paid Ball Program for Seasonal Courts only:

Seasonal/Seapro Court Group Agreement

- **Cancellations & Refunds:** You and your group may cancel this contract without further obligation and for a full refund within three days from the date of registration.
 - From three days after registration through **May 1st**, cancelled courts will be refunded except for the **non-refundable deposit**.
 - **After May 1, 2024 the entire court fee is non-refundable for cancelled courts unless resold for the season.**
- **The club does not rent a "specific" court.** The club rents only the day and time on any available court. Courts may be reassigned at any time at the discretion of the management.
- Courts may only use the facilities' teaching staff. **No outside teaching professionals are allowed to teach or use the facilities' teaching equipment.**
- The group will be responsible for any applicable federal, state, or local taxes that might be levied against these fees during the course of the season. This responsibility will not be waived even if the taxes are levied retroactively. Fees currently collected do not include any such taxes.
- No rebate, credit or makeup time shall be due for loss of group's reserved court time due to circumstances beyond the control for Yonkers Tennis Center, such as acts of God, strikes, etc.
- Court time unused by the playing **group** because of personal reasons or holidays cannot be made up. However, in the event your **group** is unable to use your court time and wish to resell it, you must notify the club in writing. If any portion of the court is resold you will receive a makeup. As a courtesy, a **maximum of three dates are allowed per season** and all makeups must be taken before the last day of the season. The captain is responsible to check if the court was sold.
- Management reserves the right to provide instruction on adjacent courts.
- Management reserves the right to change all or part of this offering without prior notice.
- The use of the center is strictly at the player's risk. The center is not responsible for injuries, accidents or damage to any person or to personal property arising from normal athletic activities in the premises. All groups and their guests hereby waive any claims for damages arising from their use of center facilities.
- All players must have a liability waiver on file prior to participating.
